The previous inspection on 8/15/2006 noted only one storage silo present and a batch (droppoint) baghouse.

The inspection on 6/21/2007 noted that two silos were now present. The newer unit was said to be a fly ash silo. Both silo units appeared to have separate dust control units located on top.

Site conditions were sunny and slightly windy. The equipment was in operation.

The pressure gauge on the batch (droppoint) baghouse did not appear to be operational. Some yard dust was present from yard traffic. The batch (droppoint) area appeared to have some excessive dust loss, which denotes the possibility that the area may need a better wind barrier (enclosure) around the inner curtain.

The inspector called Danny Collins, facility owner, on July 9, 2007, in regard to the installation of the newer baghouse. Mr. Collins claimed the new baghouse matched the "400 BBL auxillary silo" designation listed in the original permit application, and was installed approximately Fall of 2006.

Mr. Collins also claimed that the newer unit had compliance testing performed around Fall 2006 as well. The inspector could not locate the test entry in the Department database, and it appeared the District office had not received any test copies either.
