COMMENTS: Spoke to Kyle Forehand, General Manager; and Mike Nowling, Maintenance. They indicated the following:

- 1) Operation began in late October or early November 2007;
- 2) They have two additional silos at the site, but they have not been erected;
- 3) A ribbon mixer has been added, but does not increase capacity;
- 4) They have a four-bin aggregate silo equipped with a scale, instead of the three-bin silo mentioned in the application;
- 5) Sava Varazo, listed as the Authorized Representative on the application, no longer works for them; and
- 6) They have not conducted an initial visible emission test.

As an indication of dates of operation, the oldest pipe in the yard was dated October 25, 2007. After explaining the requirements to test for visible emissions and to submit a new notification form for process changes and equipment changes, they indicated they would schedule a test and submit a new registration form.

The plant runs off of electricity. A pile of recycled asphalt was noted at the site, and Mr. Nowling indicated they plan to spread it over the plant yard.

On March 3, 2008 the Department received a phone call and an email indicating a consultant has been hired to conduct the initial emissions test on March 13, 2008.
