COMMENTS: The inspector, Ilka Bundy, met the VE reader, Cara Howes, from General Environmental Engineering on February 1, 2007. A visible emissions test was conducted on the cement silo to obtain a general permit. This facility was originally found to be operating without a valid air permit; therefore, this compliance test was needed for the application process. The test results were submitted to FDEP along with the application. The inspector called the consultant to request a copy of the test report. The test report was mailed to the inspector, as requested. The observed opacity was zero percent. The loading rate was 27 tons per hour. There is no truck batching done at this facility. This facility batches its product into a wheelbarrow and the product is poured into molds to make architectural products. The yard is partly paved, part dirt, and part grass. There were no unconfined or uncontrolled emissions. The general permit was issued on 3/19/07.
