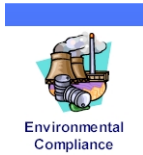

**COMMENTS:** The inspector, Bill Rhodes, with OCEPD, arrived on-site at approximately 7:45 AM, on December 17, 2008. The consultant, Doub Bauman, representing General Environmental Engineering, arrived on-site at approximately 8:15 AM. The President of the company, Mr. Chris Traicoff, was also present on-site at the time of the visible emissions test. The tanker truck (#3340) arrived on-site at approximately 8:00 AM. A visible emissions test was conducted on the cement silo to satisfy permit requirements. The observed opacity was zero percent. The loading rate was 35.4 tons per hour. There continues to be no truck batching at the facility. There were no unconfined/uncontrolled emissions observed. OCEPD left the site at approximately 9:00 AM.
