The central dust collector controls emissions for the both compartments of the split silo and truck loadout. The central dust collector is a Stephens SLS 6100 that uses Stephens ECO 23W pleated cartridges.

The single compartment silo is equipped with a C&W CP 305 silo top baghouse.

Weigh hopper emissions are controlled by a baghouse of unknown make and model.


