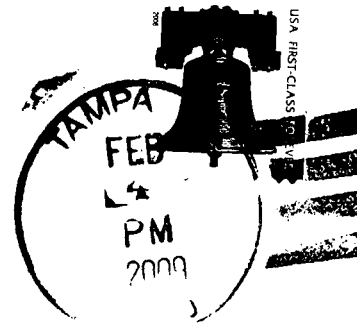
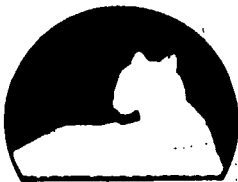
The facility is for building FRP boats. Two processes emit styrene:

- 1) A low pressure gun spraying general purpose resin in an open molding process. Although some "chopping" is done, the majority of the use is for wet out in a hand lay-up operation using felt rollers.
- 2) A low pressure gun spraying gelcoat into an open mold.

No pollutants are discarded and solvents are recycled.
